## **1. Legal base**

### **Art.1**

- (1) The organization and conduct of the process of admission to the postdoctoral advanced research programs in the “Mihai Viteazul” National Intelligence Academy shall be conducted in accordance with the following provisions:
1. Law of National Education no. 1/2011, with subsequent amendments and additions;
  2. Government Decree no. 681/2011 for the approval of Doctoral University Studies Code, with subsequent amendments and additions;
  3. Order No. 6102/2016 on the approval of the Framework Methodology for the organization of admission to university bachelor, master and doctoral studies, with subsequent amendments and additions;
  4. Order No. 3473/2017 on the approval of the Methodology for receiving to courses and schooling the foreigners starting from the school/university year 2017-2018;
  5. Regulation on organizing and conducting postdoctoral advanced research programs in IOSUD ANIMV (2022);
  6. Internal regulations issued by the Romanian Intelligence Service (SRI) on the selection and assignment process for military personnel.

## **2. Organization of the selection process for admission to the postdoctoral advanced research program**

### **Art. 2**

- (1) Only persons who have obtained a diploma of doctor in science up to 5 years prior to their admission to the post-doctoral program or who have participated and obtained the certificate of excellence in the “Marie Skłodowska Curie” competitions organized by the European Commission, irrespective of when they acquired the title of doctor, have the right to participate in the selection process.

### **Art. 3.**

- (1) The postdoctoral advanced research program shall be organized in the field of doctoral studies of Intelligence and National Security in the Doctoral School for Intelligence and Security.
- (2) The postdoctoral advanced research program shall be organized and carried out in the following forms:
- a) Full-time education, budget funded (with scholarship);
  - b) Full-time education, funded from other legal sources (with scholarship);
  - c) Part-time education, tax-free;
  - d) Part-time education, tax-funded.
- (3) The number and distribution of vacancies for each type of education shall be fixed annually, from January to February.

### **Art 4.**

- (1) Application for vacancies for full-time education form, with funding from the State budget or with funding from other legally constituted sources (with scholarship) require the signing of a fixed-term employment contract as a scientific researcher (post-doctorate).

### **Art. 5**

- (1) The application for vacancies for part-time education, tax-free or tax-funded, does not involve the signing of a fixed-term employment contract as a scientific researcher (post-doctorate).

**Art. 6**

- (1) Candidates who opt for vacancies for full-time education, with funding from the state budget or with funding from other legally established sources (with scholarship) and who are not employed in SRI will apply to the Commandant (Rector) of ANIMV in order to start the selection procedures for appointment, as described in Annex SEL01.
- (2) Applications for entry into the selection process shall be sent to the Commandant (Rector) ANIMV by 31<sup>st</sup> March each year.
- (3) Candidates will undergo the selection process for employment, specific to the Romanian Intelligence Service, from April to August.

### **3. Organization of the admission competition to the postdoctoral advanced research program**

**Art. 7.**

- (1) A Committee for Admissions and a Committee for Appeals shall be set up, proposed by the ISN Doctoral School Board and approved by the CSUD, for the organization and conduct of the competition for admission to the postdoctoral advanced research program.
- (2) Scientific coordinators shall also be part of the Admissions Committee, for candidates on the vacancies allocated to them.
- (3) Persons in relation to spouses, in-laws and relatives up to grade III, including candidates, scientific coordinators or who have benefited in the last 3 years prior to the evaluation, or are currently benefiting from advantages of any kind from the person under assessment, may not be appointed to the Admissions Committee or to the Appeals Committee.

**Art. 8**

- (1) Candidates who, on the 1<sup>st</sup> of September, meet the following conditions may apply to the competition for admission to the postdoctoral program of advanced research on vacancies with full-time education, with funding from the State budget or with funding from other legally constituted sources (with scholarship):
  - a. have obtained the diploma of doctor 5 years before the 1<sup>st</sup> of September or at any other time, if they have obtained the certificate of excellence in the "Marie Sklodowska Curie" competitions;
  - b. are employed or meet the conditions for being called into service in the Romanian Intelligence Service.
- (2) Candidates who, on 1<sup>st</sup> of September, meet the following conditions may take part in the competition for admission to the postdoctoral advanced research program on vacancies in tax-free part-time education:
  - a. have obtained the diploma of doctor 5 years before the 1<sup>st</sup> of September or at any other time, if they have obtained the certificate of excellence in the "Marie Sklodowska Curie" competitions;
  - b. are employed in the Romanian Intelligence Service.
- (3) Candidates who, on the 1<sup>st</sup> of September, meet the following condition may apply for admission to the postdoctoral program of advanced research on vacancies in part-time education, funded through a fee:
  - a. have obtained the diploma of doctor 5 years before the 1<sup>st</sup> of September or at any other time, if they have obtained the certificate of excellence in the "Marie Sklodowska Curie" competitions.

**Art. 9**

- (1) Once the admission procedure has been completed, the candidates declared admitted shall be registered and, after signing the contract for postdoctoral advanced research,

they obtain the quality of postdoctoral researcher.

**Art. 10**

- (1) The dossier for admission to the postdoctoral advanced research program shall be established and submitted in accordance with the provisions of *the Procedure for the organization and conduct of the competition for admission to the postdoctoral advanced research program in ISN*.
- (2) The doctoral school shall ensure the transparency of the procedures for selection and admission to the postdoctoral advanced research program, as well as access to this information, by displaying the public offer for the postdoctoral advanced research program and the conditions for admission at least 6 months prior to the admission contest, as well as the candidates and the outcome of the admission contest, on [www.animv.ro](http://www.animv.ro).

**3. Final provisions**

**Art.11**

- (1) This *Methodology* shall enter into force starting from the second semester of the academic year 2021-2022.
- (2) This *Methodology* shall be updated whenever necessary and when there are incident legislative changes.
- (3) Any previous provisions shall be repealed on the date of entry into force of this *Methodology*.
