Intelligence and Security Culture (ICS) - Author's Guide

The following guide aims to assist authors in their scientific endeavors. We thank everyone who wishes to join the ICS community!

SELECTION STAGE involves checking to what extent the proposals meet the following criteria:

- alignment with Intelligence and National Security studies;
- maintaining an original character and ensuring the work has not been published before;
- clear research objectives and methodologies;
- upholding a scientific nature based on argumentation, objectivity, and neutrality;
- drafting the work in accordance with set academic standards;
- acknowledgment of all used bibliographic sources.

EDITING RULES

- articles must be written in Romanian or English;
- the title should be concise and relevant;
- the abstract should be in English;
- 4-6 keywords or phrases that describe the subject of the paper;
- articles should be between 5,000-6,000 words;
- the format should be A4, using Cambria font, size 12, single spacing, and Justified alignment;
- save as a Word document (.doc/.docx), and the file name should contain the author's name and the title of the work, without diacritics.

STRUCTURE

Title - written in uppercase, centered, bold, font 14. The title should reflect the content of the work and be specific, descriptive, and concise. There should be four empty lines before the title and one after.

Author Details - first name, last name (centered) with a footnote added indicating institutional affiliation, city, and email address.

Abstract - ranging between 200-300 words, drafted in italic characters, size 10, single spacing. It should briefly reference the research purpose, main results, and conclusions. There should be two empty lines before and after the abstract.

Keywords - 4-6 keywords or phrases that describe the paper's topic.

Article Text - must follow the IMRaD model (i.e. introduction, methodology, results, discussion) and also include: current research in the field; purpose and objectives; methodology; results; personal contributions; conclusions.

Tables/graphics/images - can be incorporated with references from the text. For tables, write above, "Table No. X: title", and for images e.g. maps, etc., write below "Figure No. X: title", mentioning the source. Images can be included if there's proof of copyright ownership during the publishing process.

Annexes to the article are not accepted. However, references to sources containing the relevant information can be made.

BIBLIOGRAPHIC REFERENCES

- should be organized alphabetically;
- must adhere to the Chicago, author-date style;
- they should be numbered with Arabic numerals, aligned Justified, and drafted in Cambria font, normal style, size 11, with single spacing.

SCIENTIFIC EVALUATION

- The scientific evaluation is of peer-review type, carried out by the ICS Peer-review Committee.
- In the initial phase, abstracts are thematically checked by the ICS Editorial Board. Following this check, the author of the abstract might receive acceptance or rejection for participation in the ICS conference. In case of abstract acceptance, the author is obligated to submit the full version of the manuscript by the date established in the conference calendar, prior to the conference's commencement.
- The full version is evaluated by the ICS Editorial Board for fitting within the ICS theme and undergoes plagiarism detection. If the manuscript fits the thematic requirements and reaches the Doctoral School of ANIMV's anti-plagiarism standards, the manuscript is forwarded to the ICS Peer-review Committee for scientific assessment.
 - Authors are fully responsible for the originality of the paper and its ownership. The use of *artificial intelligence applications* is allowed for methodological purposes, as: documentation, source and author identification, structure, results verifications; and for illustrative purposes: graphical / cartographical representations, algorithms, schematics, tables. AI applications may be used by the authors with the explicit mention. Using AI text within the paper is forbidden.
- The results of the scientific assessment will be communicated to the authors, and the submitted articles for publication might fall into one of the following categories: accepted without changes; accepted with minor changes; accepted with substantial changes; rejected. Authors might be requested to make adjustments to their text based on the feedback received.
- After review and acceptance, the paper will be included in the ICS publication. Authors will receive a digital copy of the publication.
- ICS only accepts works that represent the authors' own contributions, except where explicit permissions and proper citations exist.
